
### **Get Out and Vote on November 3!**

When people in an area get out and vote, that neighborhood has a stronger political voice in the future. Politicians and others pay more attention to areas where people care and vote. They don't have to worry about serving areas where people aren't voting.

### **Letter from the President**

### **Bates-Hendricks 2015 Abandoned Housing Report**

Every year for the past seven years, Bates-Hendricks residents have fanned out across the neighborhood to identify, count, and rate the vacant and abandoned housing in our neighborhood. This information has allowed us to create an annual "problem property" list of the worst properties, as well as keep abreast of trends in our neighborhood. In addition, it has positioned us to better inform and influence City policy around demolition and rehabilitation in our neighborhood. Based on the recent survey, we can draw many conclusions about housing trends.

In September of 2014, there were 168 vacant or abandoned houses in our neighborhood. In the past vear:

- At least 14 were rehabbed / repaired
- 4 were demolished
- Average condition of the vacant houses is slightly better; this is partially due to the fact that homes are being stabilized prior to rehab

This October, we found 165 vacant and abandoned houses. This is a small decrease of 3 vacant houses. In the past year, 53 houses became vacant or abandoned; the average condition of these houses was just over 6 points. This actually means that many of the newly vacant properties are in better condition than what they were in the past. I feel that this is partly because many of the homes in better condition are being rented/sold much more quickly.

Of the present 165 vacant or abandoned houses:

- 53 are in serious disrepair
- 47 are in some disrepair
- 43 are vacant, but in repair
- 22 are vacant, and are in good shape

The big takeaway that excites me about this is that for the third year in a row, many more homes have been rehabbed than demolished. Even more exciting is that in the previous years much of the rehab work was spurred by non-profits working in the area. This year, the rehabs were all taken up by private investors and/or homeowners. Additionally, there are many more rehabs in progress – soon we will no longer know the meaning of abandoned houses in this neighborhood!

The Abandoned Housing Survey will be discussed in detail on Monday, November 2 as part of the Neighborhood Association Meeting. At that time, we can further discuss the results from the survey and determine the strategy we want to address our worst houses. # **Leaf Collection Starting Up Again Soon**

The Indianapolis Department of Public Works (DPW) will collect leaves from Marion County residents from Monday, November 9 to Friday, December 4.

Residents may place up to 40 bags of leaves per household at the curb for collection each week in addition to their regular trash. Residents should place leaf bags curbside on the day of their regular trash pickup for collection. Residents need to have leaf bags and regular trash at the curb by 7:00am to ensure collection.

### **Guidelines:**

- Place leaves in plastic or specially built paper yard waste bags.
- Place leaf bags outside by 7:00am on your regular trash day.
- Residents with trash carts must keep all leaf bags at least 3 feet away from trash carts. Regular trash that is not inside the cart will not be picked up.
- Clear leaves and debris from storm drains to avoid flooding and drainage problems.

Please remember that open burning of leaves is illegal in Indianapolis/Marion County.

Leaves collected during the 2015 leaf season will be taken to Southside Landfill where they will be turned into compost. When ready, the compost is made available to Indianapolis residents at no charge. Please call Southside Landfill at 247-6808 for availability of compost.

# Storm Water Rate Change for Fall 2015 Tax Statement

The storm water rate change should be reflected on your Fall 2015 property tax statement (due by November 10). Because of the change, the amount due for the Fall will probably not match what you paid for the Spring 2015 installment.

Storm water fees for all types of parcels (residential, commercial, churches, schools, etc.) will now be calculated based on the City's measurement of the impervious surface area on the parcel. Due to our small urban lots, this means most of us will only be facing about a \$1/month increase.

With the storm water user fee restructuring, the City can begin addressing the \$320 million in storm water capital infrastructure needs and better maintain the existing system. An updated storm water master plan, including a high priority list with \$81 million in projects to be completed through 2018, will alleviate neighborhood and street flooding, improve water quality in our rivers and streams, improve streets and sidewalks, and resolve many drainage complaints.
