Interstate Updates

There are a number of current happenings related to the I-65 and I-70 interstates that form the north and east boundaries of the neighborhood. A summary of each follows, and resources can be viewed and downloaded from our website at *bateshendricks.org/I65-70S*.

I-65 SAFE Project

The I-65 SAFE project is an Indiana Department of Transportation (INDOT) project that is doing bridge and road maintenance on I-65/70 to the east of the neighborhood, adding an additional lane and width at the Morris/Prospect overpass, and supposedly will be making



some minor pedestrian improvements at the Morris/Prospect bridge in the form of widened sidewalks. They have not been very receptive to public feedback to date, but are proceeding with design and anticipate construction running from 2025 to 2027. More at *i65safetyandefficiency.com*.

ProPEL Study

The ProPEL study is an INDOT exploration to reexamine what the interstates downtown could look like as the aging infrastructure is replaced, such as a recessed interstate with "caps" that reconnect neighborhoods. They are actively seeking input from the public before any design work takes place. The Morris/Prospect bridge was originally in their purview, but they have seemingly relinquished their authority,



meaning the I-65 SAFE project will likely move forward despite public remonstration and preclude major improvements for the Morris/Prospect bridge as part of ProPEL for at least the next 20 years. More at *propelindy.com*.

Rethink I-65/70 Coalition

The Rethink 65/70 Coalition is a community organization that is getting their own grant funding and doing their own studies to show what is possible with our interstates. They are working with Bates-Hendricks and other affected neighborhoods to envision and advocate for major improvements to our neighborhoods that have been so adversely impacted by the interstates. Interstate Lighting


