The event features local artists and musicians, community booths, kids play area, as well as food and drink vendors. Most activities will be free or low-cost to ensure the event is accessible and welcoming to all members of our community. AES Indiana Requests Another Rate Increase

AES Indiana is seeking a rate increase (www.citact.org/aes-rate-hike-2025) that would authorize them to collect nearly \$200 million in additional revenue from customers each year and raise the average monthly bills for residential customers by more than \$30. This is on top of record electric bills that households are already paying this summer and previously approved rate increases that are still being added to customer bills, as reported in the Indiana Capital Chronicle. According to an analysis by Citizens Action Coalition (CAC), if approved, this request would increase AES Indiana's profit by 60% and force residential customers to further subsidize large commercial customers like factories and data centers.

The BHNA Board has heard from neighbors who were impacted by recent power outages and higher bills. We invite neighbors to join us in contacting the Indiana Office of Utility Consumer Counselor (OUCC) to ask that they reject this unreasonable rate request.

Here's what you can do:

- Use the one-click action form on the Citizens Action Coalition website (www.citact.org/aes-rate-hike-2025) to submit written comments opposing the rate increase. CAC is also hosting an in-person town hall to learn more on Wednesday, August 6 at 6:30pm at their offices at 1915 W. 18th Street, Suite C, Indianapolis.
- Submit your own comments to the OUCC by emailing uccinfo@oucc.in.gov by September 2. Be sure to mention that you're an AES Indiana customer and the rate case cause number 46258.
- Two or more in-person field hearings are expected to be scheduled in August in Indianapolis where AES Indiana customers can make comments and attend to show public dissatisfaction with the rate increase. FACE Animal Clinic Offering Discounted Spay/Neuter Surgery

Thanks to donors who support the FACE Spay it Forward Fund, FACE is offering a 25% discount on spay/neuter surgery through August 28. The discounted prices are \$158 for dogs and \$102 for cats. There are two ways to request this financial assistance: add "Beat the Heat" to the notes section in the online scheduler at www.faceanimalclinic.org or submit your name and phone number with this form www.bit.ly/Beattheheat25 and a representative from FACE will give you a call within two business days to make an appointment.



Dogs and cats must be at least three months old and weigh three pounds to receive spay/neuter services. Pets must be up to date on their rabies vaccine. The vaccine cost (\$25) will be added to the services if needed. A \$65 deposit is required for cats while a \$95 deposit is required for dogs. This offer is only available while the extra funding lasts. Additional discounts in addition to special pricing may be available – just ask! Limit three pets per household.
